## RELEASE AND WAIVER OF LIABILITY

In consideration of my being allowed to participate in Wildlands League's Polar Bear Swim, commencing at 10:00am on Sunday, December 13, 2009 I am signing this release in favour of Wildlands League and its directors, officers, staff, members, and relatives of all these persons. I understand that although Wildlands League has taken appropriate measures for accommodations of safety of the participants, I am solely responsible for my own safety and well-being during and following said Polar Bear Swim. I assume this responsibility being aware of the dangers of personal injury inherent in but not limited to swimming and other related activities during the Polar Bear swim.

I understand that I have the sole obligation to inspect and satisfy myself as to the suitability of the conditions I will be subject to on the day of the Polar Bear Swim. I understand that I may chose not to participate at any time without repercussion. I hereby release Wildlands League and all the persons mentioned in paragraph one above from all claims or demands for loss, injury or death, however arising, while I am participating in the Polar Bear Swim. I also release any claim or demand that might be made by my relatives, executors or any other person or entity because of my loss, injury or death.

### PHOTOGRAPHY, FILMING, ETC.

I authorize Wildlands League to photograph me and acknowledge that all photographs become the property of Wildlands League and will be used exclusively for the programs and advocacy efforts of Wildlands League.

### I solemnly state:

- (a) that I have read and understand the foregoing upon the reverse
- (b) that this document must be properly completed and handed to the registration coordinator for witnessing before I will be allowed to participate in the Polar Bear Swim. The registration coordinator may allow others to take his/her place as witness.
- (c) That I waive any and all claims which but for this waiver I may have or hereafter acquire against Wildlands League, their employees, servants or agents, arising out of the granting of this permission, and this waiver shall be binding upon my heirs, executors, administrators and assigns.
